



## PLEASE READ CAREFULLY WAIVER AND RELEASE OF LIABILITY

In consideration of Outdoor Adventures, Inc. dba: Wahoos on the Pigeon River furnishing services and/or equipment to enable me to participate in Outdoor Adventures, Inc. dba: Wahoos on the Pigeon River activities, I agree as follows:

I fully understand and acknowledge that outdoor activities have: (a) inherent risks, dangers and hazards and such exists in my use of Outdoor Adventures, Inc. dba: Wahoos on the Pigeon River equipment and my participation in Outdoor Adventures, Inc. dba: Wahoos on the Pigeon River activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Outdoor Adventures, Inc. dba: Wahoos on the Pigeon River; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, guide decision making, including that a guide may misjudge terrain, weather, trail or river route location, and water level, risks of falling out of or drowning while in a raft, canoe, or kayak and such other risks, hazards and dangers that are integral to recreational activities and/ or use of equipment, I hereby assume all risks and dangers and all responsibility for an losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of Outdoor Adventures, Inc. dba: Wahoos on the Pigeon River, or by any other person.
